- Your child must sign up for one additional weekly barn duty session. Consult the calendar at the farm for day/time options. This will consist of typical barn dutues such as stall and paddock cleaning, grooming, feeding and moving horses.
- Appropriate attire is required. Boots or hard soled shoes with good traction, hats, gloves and warm jackets for cool days and evenings, a pair of work gloves is recommended. Kids will get dirty, muddy and be in contact with feed, hay, manure, dirt, water, hair and grooming products.
- A waiver must be signed prior to any child participating in our programs.
- Because of the nature of working with animals, the unpredicatibily of animals, and the need to maintain a calm environment when working with animals, for everyone's safety, children are expected to listen to the instructor at all times, be kind and respectful of instructors and fellow participants, and show kindness and

compassion towards the animals at all times. Any child found to be verbally or physically abusive to participants or animals will not be allowed to continue in the program.

- Parents are welcome to observe classes, but must not attempt to intercede in any way except where due to the health, safety and welfare of participants or animals.
- If a parent has a comment, suggestion, issue, complaint, etc. about the program, please reach out to us before or after a class session, not during. The instructor maintains all control during the sessions and cannot be interrupted.
- Participants must be on time to both class and for barn duty. Taking care of animals is a responsibility and horses made ready and left unattended while waiting for participants effects the flow of class time. If you aren't able to provide reliable, on-time transportation for your child, please do not commit to the program until you know you can.
- There are no refunds for unused classes. You can do make-up classes for your unused time from vacations, illness, etc.
